31st PSVA Annual Art Exhibition 2018 Conditions of Entry

Please read carefully

The Exhibition is open to all financial members who may submit up to 3 pastel works.

The combined size of the works to be:

- One Framed painting with a maximum width of no more than 1.25 meters plus one miniature. Or:-
- Two Framed paintings with a total maximum width of no more than 1.25 meters plus one miniature
- The frames of miniatures should measure no more than 20 cm x 20 cm
- 1. **Original work only** No physical assistance with the work. Copies of other artists' work or the use of any photographs used for inspiration not taken by the artist, or with no written permission given by the photographer contravenes the Copyright Act and will not be accepted.
 - Mixed media works accepted providing the work is 80% soft pastel.
- Entries must be received no later than 24th September 2018.
 Late entries or changes made to paintings, painting titles or prices after submission of

Entry Form **WILL NOT be accepted under any circumstances**

- A non- refundable entry fee of \$18.00 each for large paintings and \$10.00 each for miniatures must accompany this entry form
- 4. All works must be for sale
- A 25% commission will be taken on all sales
- 6. Framing must be of professional standard
- Entries will be free of damaged ill-fitting or loose frames.
- Entries with dirty or crooked mat boards will not be hung.
- Use only D rings and wire. Parachute cord will not be accepted.
- Wire must not appear above the top of the frame.
- No protruding hooks or screws allowed.
- 7. The name of the artist, contact phone number, title and price must be attached to the back of the painting.
- 8. Paintings must be delivered to the Gallery between Saturday 6th and Sunday 7th
 October inclusive. Between 1.00pm and 4.30 pm. All paintings must be delivered free from any shipping, handling or delivery charges.
- Unsold works must be collected from the Gallery on Sunday 21st October2018 between 3.00pm and 4.30pm.
- 10. While all possible care will be taken with paintings, insurance against theft or damage is the responsibility of the artist.
- 11. The Gallery has a full-time manager to conduct sales. However, members are encouraged to attend during the exhibition to talk to visitors.
