Painting Categories

Entry forms must indicate which Category you are entering for each painting e.g. A or F

Category	A:	Best Landscape (includes cityscapes)
Category	B:	Best Waterscape (pictures dominated by water in any setting: sea, river, lake, pool)
Category	C:	Best Portrait / figurative
Category	D:	Best Still Life / Floral / Interior
Category	E:	Best Animal / Wildlife
Category	F:	Best Abstract. Non-representational
Category	G:	Best Miniature (painting up to 10 x 10cm; frame no more than 20 x 20cm)

Award Categories

*Best in Show

*Best in Show runner up

*The 7 Categories will attract a Best of award.

*10 Highly commended awards will be awarded by the judge across all categories

*PSVA Award – open to artists who have not previously won a major award at a PSVA exhibition

*Margaret Lourey Award -open to artists who have not won an award at any exhibition

*Ming Mackay Award- people's choice (voting at exhibition) awarded at the December 2019 general PSVA meeting.

No painting shall win more than one award, excluding the Ming Mackay Award.

The judge's decision is final, and no correspondence will be entered into.

Conditions of Entry. Please read carefully

1.The Exhibition is open to all financial members who may submit up to 3 pastel works.

The combined size of the works to be:

*One Framed painting with a maximum width of no more than 1.25 meters plus one miniature.

Or: -

*Two Framed paintings with a total maximum width of no more than 1.25 meters plus one miniature

*The frames of miniatures should measure no more than 20 cm x 20 cm

2.Original work only – No physical assistance with the work. Copies of other artists' work or the use of any photographs used for inspiration not taken by the artist, or with no written permission given by the photographer contravenes the Copyright Act and will not be accepted.

3.Mixed media works accepted providing the work is 80% soft pastel.

4.Entries must be received no later than **Mon 19th August 2019.**

Late entries or changes made to paintings, painting titles or prices after submission of Entry Form WILL NOT be accepted under any circumstances.

5.A non- refundable entry fee of \$18.00 each for large paintings and \$10.00 each for miniatures must accompany this entry form or be paid by direct deposit to the PSVA.

6.All works must be for sale

A 25% commission will be taken on all sales

7.Framing must be of professional standard

Entries will be free of damaged ill-fitting or loose frames.

Entries with dirty or crooked mat boards will not be hung.

Use only D rings and wire. Parachute cord will not be accepted.

Wire must not appear above the top of the frame

No protruding hooks or screws allowed.

The artists name contact phone number, title of the painting and the price must be attached to the back of the painting.

8.Paintings must be delivered to the Gallery between **Saturday 31st August and Sunday 1st September inclusive. Between 1.00pm and 4.30 pm.**

All paintings must be delivered free from any shipping, handling or delivery charges.

9.Unsold works must be collected from the Gallery on Sunday 15th September 2019 between 3.00pm and 4.30pm.

10.While all possible care will be taken with paintings, insurance against theft or damage is the responsibility of the artist.

11.The Gallery has a full-time manager to conduct sales. However, members are encouraged to attend during the exhibition to talk to visitors.

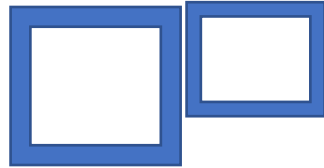
